**Hazardous ingredients:** DISTILLATES (PETROLEUM), HYDROTREATED HEAVY NAPHTHENIC >60%

## 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.
